How does Andover State Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Andover State Bank collect my personal information? Affiliates	 Companies related by common ownership or control. They can be financial and non-financial companies. Andover State Bank does not share with our affiliates.
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and non-financial companies. The Nonaffiliates we share with can include third parties to assist us in servicing your loans or accounts with us, government entities in response to subpoenas and credit bureaus.
Joint Marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Andover State Bank may market jointly with nonaffiliated financial companies.
